WHEN? Expected launch of issuing e-ID
cards: 1st July 2010

FORMAT?

Polycarbon card, format ID 1
(size of a credit card)

Identity card

- will remain to be the main identity proof document (printed visage is the main identification tool for the citizen)
- moreover it will serve now as an electronic „ticket“ to the information systems of public administration through the card number

MACHINE READABLE DATA WRITTEN INTO

- Machine readable zone

- card code
- issuing country code
- card number
- date of birth
- sex
- date of validity
- citizenship
- full name
- check digits expressing selected data in the machine readable zone

- 2D code

- agenda identifier of natural person (AIFO)
- document number

TYPES OF ISSUED IDENTITY CARDS

- with machine readable data, 2D code and with electronic contact chip
- with machine readable data, 2D code, without electronic contact chip
- without machine readable data
(will be issued in exceptional cases and with a limited validation period only)



IDENTITY CARD WILL BE ISSUED TO:

OBLIGATORY

- citizens of the Czech Republic of age >15 years with a permanent residence address in the Czech Republic

VOLUNTARILY

- citizens of the Czech Republic of age <15 years
- citizens of the Czech Republic with a permanent residence address abroad
- citizens without capacity of legal acts

PROTECTION AGAINST MISUSE OF E-ID CARD

card will be protected with a **security personal code, which:**

- verifies the eligibility of electronic identification of the ID card holder for the communication with the public administration systems; works similarly as the PIN code for credit cards
- consists of a combination of at least 4 and at most 10 digits
- citizen can choose the security code after reception of the ID card and can change it at any public administration contact point
- after the third false attempt the possibility of electronic identification is blocked and can be unblocked upon request of the citizen at any local authority

DATA WRITTEN IN THE E-ID CARD

- given names
- surname
- date of birth
- place of birth
- sex
- citizenship
- citizen's photo and signature
- ID number
- date of expiry
- date of issue
- issuing authority

WAY OF SUBMITTING THE REQUEST FOR ISSUE OF e-ID CARD

personally at any local authority with
extended powers

electronically (provided the legislative
conditions are fulfilled) at any local authority
with extended powers according to the place of
residence

PRINT OF A REQUEST FOR ISSUE OF THE e-ID CARD

For printing a request for e-ID production the following data sources will be used:

- register of citizens (ROB)
- information system of citizens
- information system of passports (and from 2011 on even the information system of identity cards)

Citizens will not submit a photo themselves – this will be taken directly at the local authority with extended powers in the photo cabin.

WAY OF DELIVERING OF THE e-ID CARD

Citizen can obtain the e-ID card at **any local authority with extended powers mentioned in the request.**

LEGISLATIVE PROCESS

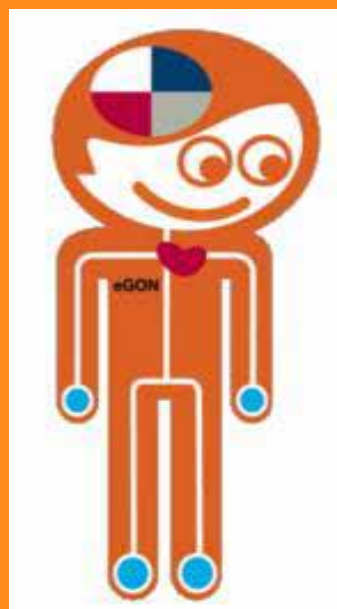
**Amendment of the Act on identity cards
concerning the e-ID (document no. 714)**

- January 2009 – proposal approved by the government (Czech Republic Government Decree from 12th January 2009 no. 63)**
- February 2009 – amendment passed successfully 1st reading in the Chambers of Representatives of the Czech Republic**
- March 2009 – amendment was negotiated in the committee for public administration and regional development**
